Wynndel Irrigation District  
Bylaw No. 220

A bylaw for imposing taxes upon lands in the District and providing for a percentage addition to encourage prompt payment thereof.

The Wynndel Irrigation District ENACT AS FOLLOWS:


1. In this bylaw "parcel means any lot, block or other area in which is the subject of separate registration in the Land Title Office and includes two or more contiguous lots registered in the name of the same person(s) and used as one holding.
2. The following taxes are hereby levied for the year 2019.
  - (A) A tax at the rate of \$372.50 per acre for the first acre or fraction thereof and \$9.45 per acre for each additional acre or fraction thereof on all lands which are or may be serviced with water from the works on Duck and Huggard Creeks and classified into Grade "A" "B" or "C" in the current assessment roll.
  - (B) A tax at the rate of \$1000.00 per acre for the first acre or fraction thereof and \$13.00 per acre for each additional acre or fraction thereof on all lands which are or may be serviced with water from the works on Duck and Huggard Creeks and classified into Grade "D" in the current assessment roll.
3. The taxes set out in the above clauses shall be due and payable on or before the thirty-first day of March, 2019 and a percentage addition of fifteen percent of the amount thereof shall be added to any such remaining unpaid after said due date.
4. In addition, taxes remaining unpaid on the 1<sup>st</sup> day of March next following the date upon which the taxes are levied shall bear interest at the rate prescribed by the Lieutenant Governor in Council under the Taxation (Rural Area) Act, as set out under Section 760 of the Local Government Act.
5. This bylaw may be cited as "First Taxation Bylaw 2019".
